


From the Editor

If you go through the recently accounted for MIA's, you will see Clifford M Mills of Tell City, Indiana. PFC Mills is the Great Uncle of Zach Montgomery (Member). PFC Mills was assigned to the 319th Glider Field Artillery Battalion, 82nd Airborne which participated in Operation Market Garden, the invasion of German occupied Netherlands. On Sept 18th 1944, he was reported missing in action in the vicinity of Wyler and Zyfflich, Germany. His remains are due to come home later on this month. There is a YouTube video (link Below) of a US Flag Ceremony honoring PFC Mills Margraten American Cemetery in the Netherlands where his name is listed on the Walls of Missing.
